21. AOCB

a) Louise McConnachie, who has horses very close to the bonfire and firework site, asked to see a copy of the insurance for the fireworks display planned for the following evening and a risk assessment.

EKCC were unable to show these. It was suggested that IB contact Kilmory the following day to find out if we were insured.

A debate ensued regarding whether the use of the fireworks was wise considering how close they are to horses and houses.

EKCC said they had originally agreed to use silent fireworks when they agreed to fund the fireworks in May - but it had not been possible to buy these.

Ronnie Brownie and Eleanor Sloan both said folk had told them they were not happy with the fireworks going off so close to animals.

It was suggested if the insurance was not in place - that the bonfire go ahead and the fireworks could be saved for another date (new year?) and a different place away from housing and animals.

The plan was to wait and see what happened with the insurance and let everyone know tomorrow

Robert Strang then said he was refusing to do the fireworks or the bonfire and none of the fire crew would be doing them.

With no one available who can safely set off the fireworks or manage the bonfire, Ian Brodie cancelled the event.

This was met with unhappiness - but there didn't seem to be any solution.

Heather Adamson suggested that next years firework display be put on next months agenda to assess the feeling in the area regarding this event.

- b) EB asked about the Rural Growth Fund and what the money could be used for Alasdair Bennett told her that the funds have already been allocated in ABC.
- c) EB told us that she has rounded up 30 stray cats and they have been neutered or spayed and then returned to where they were caught. 4 kittens were rehomed. Many thanks to the Cats Protection League. Elaine has also released 39 hedgehogs into the village
- d) Argyll McMillan asked if the grass at Waterfoot Cemetery is ever cut and the gate has fallen off. IB to discuss with Councillors
