Whilst the EKCF Trustees trust that the Village Hall committee will do all that it can to see through the project successfully, they will want confirmation that the work and fittings meet the desired standards as required by any Local Authority Registration, in terms of hygiene and safety, especially if the facilities may be used commercially.

The source of this funding will be split between the Cour and BaT3 funds, to avoid exceeding the normal EKCF limit.
